The objective of this tournament is for the CCUSBC bowlers to participate in a tournament to raise money to benefit men and women serving our country now, and those who served in the past.

TOURNAMENT RULES

1. This tournament is open to anyone wishing to bowl who pays the stated entry fee. Unmarried students under the age of 18 must file a parental consent form. All Youth bowlers must complete the Youth form that is part of this entry packet.
2. This tournament will be handicapped at 100% of 225.
3. Entrants, Adults and Youth, who are a member of CCUSBC, must use their highest CCUSBC sanctioned league average, regardless of whether bowled as a regular member or a substitute.
 - a. CCUSBC Member Averages will be accepted in the following order:
 - 1) Highest Winter 2010-2011 Book Average
 - 2) Highest Summer 2011 League Average
 - 3) Highest Winter 2009-2010 Book Average
 - 4) Highest Winter 2008-2009 Book Average
4. Entrants, who are not a member of CCUSBC, Adults, and/or do not have an average will enter as follows:
 - 1) Females will enter at 150 and Males will enter at 170
5. Youth entrants, who are not a member of CCUSBC, will enter at the following average without consideration as to gender:
 - 1) Age 16 & over will enter at 141
 - 2) Age 13-15 will enter at 119
 - 3) Age 10-12 will enter at 94
 - 4) Age 7-9 will enter at 55
 - 5) Age 6 & under will enter at 25 (no bumper bowlers)
6. The entry fee for this tournament will be **\$20.00 per person**. \$5 of each entry fee will go directly to BVL. No entry fee will be refunded. Walk-in entries must be paid in cash.
7. Individuals wishing to bowl together should submit their entries together in the order they wish to bowl. Scheduling will be on a first come, first served basis. The Tournament Manager, except for an emergency, will not change the schedule. The Tournament Manager will assign lanes. This event will be bowled on a pair of lanes.
8. Entry fees – Cash, Check or Money Order. **Make checks payable to CCUSBC**. Returned checks not made good prior to squad time will void entry. Entrant prior to squad time must pay all bank charges for returned checks or entry will be void. Full payment of all entry fees must be submitted with entry form.
9. Entries open on August 20, 2011 and walk-ins are welcome.

10. **CHECK IN: Each bowler must check in thirty minutes prior to the scheduled bowling time.**
11. Three consecutive games shall be bowled and total pins shall decide the winner. THIS IS A 9-PIN NO-TAP UNSANCTIONED TOURNAMENT. Nine or ten pins on the first ball will be recorded as a strike. Eight pins or less will roll for a spare.
12. An entrant may participate one time only.
13. Any player arriving after the game has started, will be allowed to bowl, however, scores will count beginning in their first frame bowled. No score will be given for frames missed.
14. All Adult prize money will be returned 100%. Prize checks will be distributed within thirty (30) days after the tournament closes (except when USBC has authorized delay in payment pending the settlement of any claim or protest that affects position standings). All Youth Prize Fund will be returned 100% in Scholarships to the SMART Program. No unofficial results will be announced during the tournament.
15. There will be two divisions: Adult and Youth. **YOUTH BOWLERS MUST COMPLETE AND INCLUDE, WITH THEIR ENTRY, THE ATTACHED WAIVER (page 4 of this entry form).**
16. Tournament Management shall decide any questions not covered by the Tournament rules. **The decision of Tournament Management will be final.**
17. Error in scoring must be reported to Tournament officials prior to the end of the Tournament.
18. **ALL RECAPS MUST BE SIGNED.** It is each bowler's responsibility to verify that their scores have been written correctly as all recaps are official records of scores bowled. If recaps are not signed, scores can be forfeited.
19. The Tournament Manager must be advised of substitutions at least one hour before the scheduled bowling time. In case of an emergency after a game has started, a substitute, if one is available, shall be allowed. If no substitute is available, only the actual score of the frames bowled shall count.
20. A substitute will not be required to reimburse the original entrant the fee paid nor shall the substitute be expected to give the entrant any prize money the substitute may win.
21. Bowlers will not make corrections to the scoring units or recap sheets without a Tournament Officials approval.
22. Any protest or appeal affecting eligibility or playing rules must be submitted in writing, to the Tournament Manager, in accordance with USBC Rule 329 before the tournament prize payments are made. Recaps are official records of scores bowled.
23. A tournament entrant will not be allowed to re-bowl a game or series, except as authorized by the tournament management when the scores are irretrievably lost from an automatic scoring device.
24. In the event of ties, prize money will be divided accordingly.
25. Only bowlers and officials will be allowed in the playing area. **NO** food or beverages will be allowed in the playing area. Only Tournament Officials will be allowed to program, correct and record scores.
26. Bowlers using loud or abusive language or conduct unbecoming of a bowler shall have one warning. If misconduct continues, bowler will be removed from the lanes. The bowler will forfeit any awards and prize money to that event.

To maintain my eligibility to participate in USBC Youth certified competition, I waive claim to any cash or bond prizes awarded in the above named competition. I further waive claim to any merchandise prizes exceeding \$500 in value which may be awarded in the above named competition.

By signing this form, I certify that I have read and understand Rule 400 as it applies to participating in this competition and the effect my participation may have on my USBC Youth membership. I understand that by accepting any of the prizes listed above, I am in violation of Rule 400 which subjects me to disciplinary action including the potential loss of my USBC Youth membership.

I further understand that by accepting any of the prizes listed above my eligibility to compete in high school and collegiate athletics may be jeopardized. I also understand that to ensure compliance with high school and collegiate rules I should check with a compliance officer and/or athletic/activities association prior to the acceptance of any award.

If offered, I agree to accept winnings in the form of scholarships deposited with SMART.

Rule 400

- A. Except as provided in Item B, a youth may not bowl, substitute or pace in any bowling activity which offers any of the following as prizes:
1. Cash or bonds.
 2. Merchandise exceeding \$500 in value.
- B. Youth may bowl in singles competitions (including side competitions/brackets) offering such prizes, provided, prior to bowling:
1. The competition agrees to award the youth's prize in the form of a scholarship; or
 2. The youth signs a form waiving his/her rights to any prize in violation of this rule.

In youth competition, youth members may participate in side competitions/brackets provided all entries are returned 100% in the form of scholarships only and awards comply with Item A above.

Buying or selling of earned prizes is prohibited.

Any youth bowler deemed in violation of this rule is subject to disciplinary action including the potential loss of youth membership.

NOTE: There are no limits on scholarship amounts or entry fees (must be paid directly to the tournament director/manager) and reimbursement of actual travel expenses into the next higher level of competition or any tournament or event. (Receipts must be provided upon request.)

The prizes authorized by a state high school athletic association or a collegiate athletic association recognized by USBC and USBC Collegiate are not subject to the limitations of this rule.
