1. Entrants may be male or female.
2. All current USBC members in good standing are eligible. Unsanctioned bowlers may enter by paying the appropriate National membership dues.
3. Entry fee is \$100.00 - Lineage of \$15.00, expenses of \$5.00 and prize fund of \$80.00. Pre-registration for this tournament ends on October 19. Walk-in bowlers will be allowed to enter one hour prior to the start of the tournament and are subject to \$10 late-entry fee.
4. All bowlers will bowl 6 games of qualifying, moving one pair to the right after each game.
5. Number of qualifiers for match play will be determined as follows:
 - a. 16-31 entries – top 4 qualifiers advance directly to a stepladder final.
 - b. 32-63 entries – top 8 qualifiers advance a two-game total score, match play semi-final; semi-final winners advance to one-game stepladder final.
 - c. 64+ entries – top 16 qualifiers advance a two-game total score, match play quarter-final; quarter-final winners advance a two-game total score, match play semi-final; semi-final winners advance to one-game stepladder final.
6. All match play will be broken with a best ball roll-off, with the higher seed selecting the lane and order. Qualifying ties will be broken with a best ball roll-off, with the roll-off lanes determined by the tournament manager and lane and order determined by coin toss.
7. Prize fund payout will be 1 in 4 with the prize fund will be returned 100%. Prize fund payouts will occur within 30 days of the conclusion of the tournament. Additionally, the winner will receive a paid entry to the following year's tournament (entry is not transferrable).
8. Oil pattern will be a Kegel challenge pattern designated by the CCUSBC president and will be revealed on the tournament date. Anyone with advance knowledge of the pattern is ineligible to bowl. There will be no re-oiling between qualifying and match play.
9. All bowlers will observe a one lane courtesy.
10. Check-in opens at 8:00 a.m.
11. All USBC Rules not mentioned will apply. Tournament Management shall decide any questions not covered by the rules. The decision of Tournament Management will be final unless appealed in accordance to USBC Rule 329.
12. Suitable attire must be worn; tank tops and clothing with obscene language or gestures will not be allowed during tournament play. Final determination of proper attire will be at the discretion of the Tournament Director or their designee. In addition, electronic devices will not be allowed during tournament play.
13. Entrant is responsible for all returned checks. A \$40 collection fee will be charged.
